Prepaid Gasoline Sales Tax Rate. Effective November 1, 2020, the new prepaid gasoline sales tax rate is 10.4 cents per gallon. This rate will remain in effect through November 30, 2020. Prepaid Diesel Sales Tax Rate. Effective November 1, 2020, the new prepaid diesel fuel sales tax rate is 12.1 cents per gallon.

Sales and Use Tax Filing Deadlines. All businesses are required to file an annual return each year. The first 50% payment is due on the 20th day of the current month. The second 50% payment is due on the last day of the current month. The Reconciliation payment is due on the 20th of the following month.

Effective October 1, 2018, Michigan considers vendors who make more than \$100,000 in sales annually in the state or more than 200 transactions in the state to have economic nexus. This means the state considers these vendors obligated to collect sales tax from buyers in the state.

Annual Statement The State of Michigan requires you to file an annual statement for your LLC. You must file the statement each year by February 15. (The one exception is for new LLCs formed after September 30 of the preceding year, which don't need to file a statement on the February 15 immediately succeeding the date of formation.)

State Of Michigan Annual Sales Tax Return

The cost to file an annual report in the state of Michigan depends on what type of business you own. Profit corporations must file a report by May 15 and pay a fee of \$25 when they file. Nonprofit corporations must pay \$20 to file by October 1. Michigan foreign corporations must pay \$25 to file by May 15, while LLCs must pay the same amount to file by February 15.
